

SUBJECT: Tax Exemption Impact Report

Dear Supervisor Schneiderman:

Pursuant to Chapter 258 of the Laws of 2008, attached is the Tax Exemption Impact Report for the Town of Southampton.

GENERAL VALUATIONS

- Currently, the total assessed valuation of the town of Southampton is \$82,622,627,002.
- After subtracting the various exemptions the taxable valuation is \$76,687,012,045.

PARCEL/EXEMPTION/PILOT COUNTS

There are 52,048 total properties in the township.
There are 6,013 wholly exempt properties in the township.
There are 16,790 partial exemptions (including STAR) in the township.
The town received \$3,321,826.49 from a "PILOT" or Payment in Lieu of Taxes from LIPA/National Grid in 2022/2023.

The attached report lists each and every exemption code now in use in the Town of Southampton along with its description, statutory authority, the number of exemptions and the value of the exemption.
